Please see Horizon West Transmission’s (HWT) response below.

1. Dudek Environmental Consultants provided wildfire planning support during permitting for the initial project design and both the construction and operational fire prevention and protection plans in 2018-2019, and supported HWT’s initial (2019) and second (2020) Wildfire Mitigation Plan (WMP) submittals to the California Public Utilities Commission (CPUC or Commission).
2. Jensen Hughes provided an independent third-party assessment of wildfire risk and resiliency of the operational Suncrest SVC Facility in 2020.
3. Capstone Fire & Safety Management provided wildfire prevention and awareness services during construction of the Suncrest SVC Facility from 2018-2020. Capstone also provided operational on-call emergency support services and managed HWT’s fire truck and foam trailer in 2020.
4. A.M. Ortega Construction constructed the original Suncrest SVC Facility in 2019-2020. During construction, A.M. Ortega implemented the construction fire prevention and protection measures identified in HWT’s Suncrest SVC Facility Construction Fire Prevention Plan and 2020 WMP. A.M. Ortega is constructing the ongoing wildfire improvements from 2020-present.
5. ABB constructed the original Suncrest SVC Facility in 2019-2020. During construction, ABB implemented HWT’s construction fire prevention and protection measures identified in HWT’s Suncrest SVC Facility Construction Fire Prevention Plan and 2020 WMP.

6. Prysmian Construction Services constructed the original Suncrest SVC Facility in 2019-2020. During construction, Prysmian implemented HWT's construction fire prevention and protection measures identified in HWT's Suncrest SVC Facility Construction Fire Prevention Plan and 2020 WMP. Prysmian is constructing the ongoing wildfire improvements from 2020-present.
7. Sargent & Lundy Engineers provided engineering, project management, and construction oversight services for construction of the Suncrest SVC Facility in 2019-2020 and is providing the same services for ongoing wildfire improvements from 2019-present.
8. SWCA Environmental Consultants permitted the Suncrest SVC Facility and provided environmental construction support services in 2019-2020 and is providing the same services for ongoing wildfire improvements from 2020-present.
9. Accenture Consultants provided support for preparation of HWT's initial (2019) and second (2020) WMP submittals to the CPUC.
