PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

SUBJECT: INFORMATION-ONLY FILING REGARDING UTILITY NAME CHANGE

Horizon West Transmission, LLC ("Horizon West") (U222-E) (formerly known as NextEra Energy Transmission West, LLC) hereby submits to the California Public Utilities Commission ("Commission") an Information-Only Advice Letter filing formally notifying the Commission of its change in name.

UTILITY NAME CHANGE

The name of NextEra Energy Transmission West, LLC was changed to Horizon West Transmission, LLC. This was a change in name only. No change in ownership occurred. Attached hereto are copies of the California Secretary of State's Amended Certificate of Registration confirming the name change and the Delaware Secretary of State's certification of the name change.

EFFECTIVE DATE

This filing is subject to Energy Division disposition and is classified as Tier 1 (effective pending disposition) pursuant to General Order ("GO") 96-B. Horizon West respectfully requests that this filing become effective on September 12, 2019, which is the date of this filing.
